Complete this form and present it to your county treasurer for registration of your custom, kit, specially constructed, or street rod vehicle.

**Vehicle Definition:** (check only one)

**\*Custom vehicle** – a motor vehicle including a kit vehicle but not a motorcycle that meets all of the following criteria:

- was manufactured or built to resemble a model year after 1948; and
- is at least 25 years old or resembles a model year at least 25 years old before the current calendar year; and
- has been altered from the manufacturer’s original design or has a body constructed from non-original materials.
- Vehicle use:  General transportation  Not general transportation (**see definition below**)

**Kit vehicle** – a motor vehicle assembled from a manufacturer kit, either as:

- a complete kit (pre-fabricated body and chassis) used to construct a new motor vehicle; or
- a kit with a pre-fabricated body to be mounted on an existing motor vehicle chassis; and
- the vehicle does not qualify as a custom vehicle\* or a street rod\*\*

**Specially constructed vehicle** – a motor vehicle, including a motorcycle, that:

- was not originally constructed under a distinctive make, model or type by a generally recognized manufacturer of motor vehicles;
- has been structurally modified so it doesn’t have the same appearance as similar vehicles from a generally recognized manufacturer of motor vehicles;
- has been constructed or assembled entirely from custom-built parts and materials not obtained from other vehicles;
- has been constructed or assembled by using major component parts from one or more manufactured vehicles and cannot be identified as a specific make or model; or
- has been constructed by the use of a kit that cannot be visually identified as a specific make or model.

Note: Specially constructed vehicle does not include a motor vehicle that has been repaired or restored to its original design by replacing parts.

**\*\*Street Rod** – a motor vehicle including a kit, but not a motorcycle, that meet all of the following criteria:

- was manufactured or built to resemble a pre-1949 vehicle; and
- has been altered from the manufacturer’s original design or has a body constructed from non-original materials.
- Vehicle use:  General transportation  Not general transportation (**see definition below**)

**Not general transportation:** The operation of a motor vehicle to or from a car club activity, event, exhibit, show, cruise night, parade or other occasional transportation activity. It does not include operation of the vehicle for routine or ordinary household maintenance, employment, education or other similar purposes. If certifying that this vehicle is not used for general transportation purposes, you are entitled to display only one license plate, on the rear exterior of the vehicle, upon submission of this form and an additional \$10 fee to your county treasurer’s office.
